Please note: APA dues are not tax deductible as charitable contributions for federal income tax purposes. However, they may be deductible as ordinary and necessary business expenses. Also, second years pro-rating policy has been put into effect so all members are on the same calendar year dues schedule. When a new member joins, they will pay the full dues amount and then receive a prorated renewal notice in January for the number of months remaining following their enrollment month. In subsequent years, the member will be invoiced in full every January. The second year pro-ration policy follows the following schedule: If joining in April-June you will pay 75% of the stated membership fee in your second year of membership. If joining July-September you will pay 50% of the stated membership fee in your second year of membership. If joining October-December you will pay 25% of the stated membership fee in your second year of membership.
